ORDER:

In the reference 2nd read above, the School Education Department have stated that the Commissioner and Director of School Education had informed that many Minority Student Unions as well as Minorities Educational Rights Protection Committees have represented that it would be difficult for the candidates seeking B.Ed admissions to produce School T.C. / SSC Certificate as required under sub-clause 2 of Clause (II) of G.O. 1st read above, as the T.C. would be submitted in Junior Colleges after 10th and obtaining a duplicate T.C. would be very difficult as it requires a lengthy procedure of production of Affidavit attested by M.R.O. etc. The Organisations have, therefore, requested to exempt the students seeking admission into Minority Educational Institutions from the production of T.C. in support of their religion. It is also brought to the notice of the Government that certain private candidates without formal schooling are appearing SSC / Degree privately and in such cases there would not be any T.C. of a school for admission into Minority Educational Institutions for production as required under G.O. 1st read above.

2) The Government, therefore, after careful consideration and examination of the issue, hereby decide and accordingly order the following modifications to sub-clause 2 of Clause (II) of G.O. 1st read above:-

(i) In the absence of Transfer Certificates, the candidate should obtain a certificate from the Head of the institution in which the student studied in the following proforma. The Head of the Institution should verify the admission register and issue the certificate duly indicating the religion as mentioned in the admission register. The Heads of the Institutions shall be personally held responsible if any false certificate is issued.

(ii) In respect of the candidates who have appeared for S.S.C. as private candidate also, they shall approach the Head of the Institution from where they have forwarded / submitted their application for appearing SSC examination for issue of the following certificate:

(iii) If the candidates produce Xerox copies of Transfer Certificates of their school study duly attested by the Head of the concerned institution certifying that the individual belongs to the religion mentioned in the Xerox copy is genuine and acceptable, the same may be accepted.

(iv) In respect of candidates who have directly taken admission in Graduation in B.R. Ambedkar Open University, Hyderabad the candidates shall submit the T.Cs issued by the said university. In the absence of the Transfer Certificates, the candidate may approach the competent authority in the Open University and obtain a certificate in the proforma mentioned under S. No. (ii) above.
